



**Greetings,**

**As Black women attorneys at the NAACP, we stand on the shoulders of the women and men who have worked collectively to advance civil rights and social justice in our nation. For far too long, our unique voices as Black women have not been represented on the Supreme Court. This is a proud and historic moment because collectively, we are changing that history.**

**President Biden has nominated Judge Ketanji Brown Jackson to the U.S. Supreme Court. Aligned with our history, the NAACP has led in efforts to increase diverse representation on the Court and within the federal judiciary as a whole. We are continuing those efforts now to advance Judge Jackson's historic confirmation by the Senate.**

**The NAACP was built for this moment. Founded in 1909, we have been monitoring Supreme Court nominations since 1930 when the organization opposed President Herbert Hoover's nominee to the Court, John Parker from North Carolina because he believed that Black people had no role in the political process. At that time, the NAACP galvanized branches, testified at the confirmation hearing, and urged the Senate to oppose the nomination. The nomination was defeated!**

**In the ensuing decades, we have engaged in advocacy to both support and oppose nominations on civil rights grounds, each time after careful review of the nominee's record. We have weighed in with the Senate on every recent Supreme Court nomination--in favor or against--to ensure that all justices respect the progress our nation has made in civil rights.**

**It is long past time for a Black woman to serve on the highest court in the land. Since the Supreme Court was established in 1789, 115 justices have served and all but seven have been white men. A Black woman justice will bring a unique background, perspective and set of lived experiences to her decision-making, to her votes, and to her voice on the Court.**

**This is a critical moment in our nation's history. Judge Ketanji Brown Jackson is simply an extraordinary candidate for the Supreme Court. She has impeccable legal credentials and has already served almost a decade on the federal bench, which is more than many other sitting justices at the time of their nomination. Importantly, she would be the first former public defender ever to serve on the Court. Indeed, Judge Jackson is one of the most qualified nominees ever named by a U.S. president to the Court.**

**We are extremely proud to lend our support to advance the nomination and ensure her swift and overwhelming confirmation by the Senate. We stand shoulder to shoulder in our support, and we are asking for your help in this history-making effort. Thank you.**
